Water board updates vision for regional water system

Board members of the Southwest Water Authority (SWA) envision "People and businesses succeeding with quality water." This vision statement, adopted in November of 2003 has provided the foundation for continued work on a long-range strategic plan.

The strategic plan encompasses six major goals, such as securing additional funding from traditional and non-traditional sources, as well as, increasing the number of SWA customers. The strategic planning process has been an excellent venue to initiate dialogue between board members and staff and brainstorm innovative methods to complete the Southwest Pipeline Project (SWPP) in its entirety.

Unique agreement brings early service

It has been said that with ordinary talents, extraordinary perseverance and a willingness to work together, all things are attainable. That is just the case for two North Dakota communities and a regional water system.

For approximately 15 years, residents of Oliver, Mercer and northern Dunn counties have patiently awaited water service from the Southwest Pipeline Project (SWPP). Now, through a unique agreement between the city of Beulah and Southwest Water Authority (SWA), some customers within the Oliver, Mercer, North Dunn Service Area may receive water as soon as fall, 2006.

That particular service area is the next and final section slated for construction along the SWPP. While we realize that much work remains to secure adequate funding for the remaining construction, we are committed to doing whatever it takes to complete the project. Good news came in August when SWA received word that funding had been approved for a proposed interim water service project.

SWA and the city of Beulah are currently negotiating an agreement whereby residents of the city of Zap, Beulah's Country Club Estates, and approximately 61 customers along the service line to Zap could possibly receive rural water service as early as fall, 2006.

Under the proposed agreement, SWA would purchase water from the city of Beulah and deliver it to the city of Zap, Country Club Estates and rural customers along the service line to Zap. The proposed agreement is considered an interim water service arrangement until SWPP water becomes available in the Oliver, Mercer, North Dunn Service Area.

When SWPP formally moves into the construction phase of the Oliver, Mercer, North Dunn Service Area, the individuals served by the interim service agreement will eventually receive water from the proposed water treatment plant near Zap. Available funding will determine the time frame the proposed water treatment plant near Zap will be constructed.

We anticipate that the current construction area, the Medora-Beach Service Area, to be substantially complete by 2007, at which time efforts will begin in earnest on funding acquisition to construct the Oliver, Mercer, North Dunn Service Area in its entirety.

Update emergency numbers

In the event Southwest Water Authority needs to contact you in an emergency, updated information is critical to avoid delays. If you have a new 911 address or telephone number, please notify us. Thank you in advance! With your cooperation we will be able to maintain accurate records.

Meter readings are important

Meter readings help in the detection of leaks. Large increases in a customer's water usage pattern

can sometimes be an indication of a leak. It is difficult to see what the normal usage level is when a meter reading is only reported periodically. Customer usage patterns can also indicate a problem with a meter. From time to time, remote meters have been known to stick or not register correctly. Problems been found through

meter readings. Not reporting a meter reading consistently, will also cause your bill to fluctuate from month to month.

When meter readings are not reported for two consecutive months, Southwest Water Authority personnel will read the meter and a \$10.00 charge will be added to your bill. You can call in your meter reading by dialing 225-0241, locally, 1-888-425-0241, toll-free or e-mail swa@swwater.com. If you are not connected for service or using water, please enter zeroes or draw a line through the meter reading section of your payment stub.

No rate hike in 2006



For the fourth consecutive year, the Southwest Water Authority (SWA) Board of Directors voted to absorb the required Consumer Price Index

increase in capital repayment fees for both contract and rural customers.

"This action is consistent with the board's goal of stabilizing rates for customers...a goal that is achieved by holding down operational costs, adding customers and selling more water," according to Mary Massad, SWA Chief Financial Officer/Office Administrator. The action is also consistent with the board's philosophy that SWA is not in business to make a profit, but to manage, operate and maintain the Southwest Pipeline Project while covering costs.

Beulah public information meeting is positive

On December 20, 2005, a public meeting was held at the Beulah Civic Center. Ray Christensen, Manager/Chief Executive Officer of the Southwest Water Authority, opened the meeting recognizing John Philips for his efforts in making the Beulah project possible.

James Landenberger, Project Manager, Bartlett & West/Boyle Engineering Corporation, discussed project design, routing plans for transmission lines and the placement of curb stops/meter pits. James Lennington, Project Manager, State Water Commission, explained project funding options and requirements of the funding agency, the United States Department of Agriculture. A preliminary sign-up deadline was set for January 15, 2006, with easement acquisition beginning after final design plans are completed.

The meeting was well attended and presenters and participants both were optimistic and eager to begin construction.




