### Manager's message

Construction continues this spring in the Oliver, Mercer, North Dunn Regional Service Area. As in previous years, obtaining the necessary funding to complete construction is critical with anticipated construction costs for the biennium of \$12 to \$25 million.

This year marks another legislative session and the Southwest Water Authority (SWA) board of directors and management are working to aide in obtaining funding to complete the Southwest Pipeline Project (SWPP). At a recent monthly board meeting, the directors voted unanimously to work collaboratively with the North Dakota Water Coalition to secure legislative support for water development projects statewide. A unified approach to secure funding has proven successful in previous legislative sessions and SWA is optimistic it will again this session.

SWA is also active in numerous other events focused on educating legislators such as Southwest Night at the Legislature, Coffee with the Legislators, Water Day at the Legislature and more. These grassroots events provide an opportunity to educate legislators on the importance of funding water development projects statewide.

Senate Bill 2020, the State Water Commission's agency funding bill, is the source for construction dollars at the state level for the SWPP. SWA works diligently to solicit support at both state and federal levels to obtain the necessary funding to complete the project. The SWPP has been very fortunate in federal funding the last few years. However, as you know, there is a federal budget crisis and future funding for the SWPP is in jeopardy. Securing project funding has always been a priority.

Each year rates are carefully reviewed to determine if changes are needed. In November, at the monthly board of directors meeting, the budgeting process was completed and water rates were set for 2011. Due to rising costs of operations and maintenance, it was approved to increase treatment cost by \$.05 for the cost of water for both contract and rural customers and add \$1.00 to the rural

### Looking further into 2011

Hello Everyone!

We are busy with construction of the Oliver. Mercer, North Dunn Regional Service Area (OMND). The water treatment plant north of Zap and the Zap reservoir are currently under construction.

Bruce Koppinger The Zap Water Treatment Plant will supply water to the customers and cities in the OMND who have signed up for water service. Construction on the Main Transmission Line, from Hazen to Stanton and from

Beulah to the Center Tank, will also begin this spring. In addition, construction of the Center Tank Reservoir will commence. As you can see, there will be a lot of construction going on this year.

We will also start construction on the first rural service area this summer. This is called the Zap Service Area or Contract 7-9C. There is still time to sign up for water if you have not done so yet.

The sign-up fee is \$750.00 if you sign up before the bid date for a service area. After the bid date, the signup fee goes up to \$1,500.00. The early sign-up fee is a great bargain compared to waiting to connect to Southwest Pipeline Project (SWPP) after construction is complete in your area. Hooking up to the SWPP can costs thousands of dollars after the bid date, as after that date, it is your responsibility to hire a licensed contractor and pay all construction costs, as well as obtaining your own easements. Contact our office at 701-225-0241 or 1-888-425-0241 and we would be happy to answer any questions you may have about signing up for water service.

We also have been busy signing up subsequent customers in areas where construction is complete. If you are thinking of building or of buying land and will need water at this location for domestic use or a pasture tap for livestock, please contact our office and we will be glad to help with your water service. Thank you for your continued support of the SWPP and Southwest Water Authority.

### North Dakota Department of Health tips for medication disposal

Don't flush unwanted household medications or pour them down the drain.

#### Keep North Dakota's Water Clean!

Flushing or improper trash disposal of unused and unwanted medications can cause pollution of lakes, streams and water supplies.

North Dakota has taken steps to provide its citizens with a safe and simple method to dispose of unused drugs, helping to keep our water clean. This is free to the public. Unused prescription drugs can be disposed of safely by depositing them in the secure disposal container, located in the lobby of the Law Enforcement Center, no questions asked. In order to comply with federal laws, the local law enforcement agency will take responsibility for the collected drugs, including securing, logging and destroying them.

We are taking a proactive approach to meet the needs of our customers and the requirements of the Environmental Protection Agency and the Department of Health by reducing our fluoride level from 1.2 milligrams per liter to .7 milligrams per liter.
