2022 Rate Changes

At SWA, we strive to stabilize the cost of quality water and keep it affordable. During the past year, SWA has experienced rapidly rising costs in nearly every aspect of providing service to our customers. These costs include such items as power, labor, chemicals, and maintenance. To cover the increase in these costs. SWA's Board of Directors approved a rate increase. Rural users will see an increase of \$2.01 to the monthly minimum. Cost per 1,000 gallons will be \$6.40, an increase of four cents per thousand gallons. Water rates for communities and contracts will be \$5.71 per thousand gallons, an increase of eleven cents per thousand gallons.

SWA Announces New Manager/CEO



Upon the retirement announcement of current Manager/CEO, Mary Massad, a succession plan for her replacement began in March of 2021. The involved process began with SWA's Board of Directors selecting members for a succession planning subcommittee including five board members, legal counsel, a member of the SWC (DWR), SWA's project engineer and Massad for the next SWA Manager/CEO.

The subcommittee reviewed the job description, planned their recruitment timeline, and determined the hiring process. More than 40 applications were received. The subcommittee then held two rounds of interviews and recommended Jenifer (Jen) Murray for

the position which was ratified by SWA's Board of Directors at SWA's October Board meeting.

Jen is currently Mary Massad's Executive Assistant and has served in the position for the past eight years. Jen will be the new Manager/CEO effective January 1, 2022.

Massad stated, "It gives me great pleasure to introduce you to Jen Murray, my replacement as the next Manager/CEO for SWA. During her time as Executive Assistant, Jen has shown her dedication to SWA, the Southwest Pipeline Project, and those we serve. I know with Jen at the helm of SWA, we continue to be in good hands. 
