## Temporary service available at Southwest Water Authority

Southwest Water Authority (SWA) will supply temporary water service, provided there is water available in excess of regular needs and the material and equipment necessary to supply said services is available.

Each applicant for such service is required to pay the hookup fee (includes hydraulic study) and labor, mileage and materials (less salvage value on removal of materials) for installing and removing such service at rates established by SWA. This payment must be made in advance. Water usage will be billed on a monthly basis. The monthly fee consists of a standard hookup minimum which includes 2000 gallons of water, plus any additional gallons billed at current water rates.

Although this option has always been available, we have had very few requests in the past. However, with the drought conditions in southwest North Dakota, stock

## Water project receives \$1.5 million grant

The United States Department of Agriculture Division of Rural Development awarded the Southwest Pipeline Project (SWPP) a \$1.5 million grant for continued construction of the Scranton Bowman Regional Service Area.


The grant was accompanied by a loan for \$1.8 million, which will need to be used prior to the grant monies, according to Jim Lennington, SWPP Project Manager with the ND State Water Commission.

"Scranton is scheduled to receive SWPP water in late July," said Ray Christensen, SWA Manager/CEO. "This funding allows us to continue construction in a timely and efficient manner." Upon completion of the Scranton Bowman Regional Service Area, construction activities will begin west of Belfield.



## Quality - main reason to sign up

Southwest Pipeline Project (SWPP) water is a high quality product, according to residents in southwest North Dakota. In a recent customer survey, over 75 percent of responders ranked the water as "very good" to "excellent."

Customers speak out in recent water survey LoAnn Wegh, survey coordinator explains, "Southwest Water Authority (SWA) generally conducts a customer satisfaction survey in areas that have been receiving water for at least two years. This survey encompassed the rural areas surrounding Hebron, Glen Ullin, Bucyrus, the East Rainy Butte Pocket and Three Pockets." The survey asked customers to rank their level of satisfaction based on water quality, customer service, and reasons to sole source their water supply.

When asked what would encourage them to switch from another source of water supply to SWPP water, nearly 20 percent said "affordability," with "loss of current water source" and "volume discounts" following closely behind. Customer service received high marks, with three-fourths of respondents indicating their satisfaction level based on courtesy was "very good" to "excellent."

"We are pleased with the survey results," said Ray Christensen, SWA Manager/CEO. "Our top priority is to deliver an adequate quantity of quality water to southwest North Dakota, and to do so with hospitality."

## **Construction Update** ■ by Dan Farrell, Water Resource Engineer

Construction efforts on the Southwest Pipeline Project (SWPP) continue through the summer in southwest North Dakota.

The contractor for the Twin Buttes main transmission line, Nygard Construction Inc., has completed installation of the pipeline and is heavily involved in the chlorinating, testing, and connection completions of the main transmission line toward the Twin Buttes Reservoir north of Bowman. The city of Scranton can anticipate water service from this construction effort in late July.

Abbott, Arne & Schwindt Inc. and their subcontractor continue installation of the rural water system under Contract 7-7A Twin Buttes Service Area. This contract

includes the installation of approximately 123.2 miles of water pipe ranging in size from six-inch diameter down to one and a half-inch diameter. Completion date is September 1, 2002.

In addition, erection of the second New England Tank and Twin Buttes Reservoir has proceeded with this summer's weather. Construction of the Twin Buttes Reservoir has been completed and the tank was painted the first week of July. After the paint has cured, the tank will be hydrostatically tested and chlorinated before being placed into service. This tank will add approximately 250,000 gallons


to the storage capacity of the SWPP.

The second New England Tank is scheduled for completion August 15, 2002, and appears to be on schedule. Construction was completed the last week in June, and the tank will be cleaned,

hydrostatically tested and chlorinated before placed into service. This tank will add approximately 1,240,000 gallons to the project's storage capacity and provide operational redundancy for the south zone of the project.

Contract 7-7B/7-3C, Twin Buttes Service Area Phase II and West Rainy Butte Booster Area, was awarded to Abbott, Arnie & Schwindt Inc. of Moorhead, Minnesota on May 31, 2002, by the ND State Water Commission. The rural water distribution area under this contract includes areas west and north of Bowman. The contract has a final completion date of August 1, 2003.

Design and planning efforts continue on the project's Beach-Medora Phase. Several community meetings have been held in the area with good public representation. A consultant has been retained to complete botanical, wildlife and raptor studies in lands managed by the U.S. Forest Service. Construction is anticipated to begin in 2003, depending on the available funding from state and federal sources.

producers are now requesting this service. For example, those producers who want to use Conservation Reserve Program (CRP) acreage without available water for livestock. Temporary service for this type of user may be available, if we happen to have water lines with appurtenances nearby. Please note that this type of service is not considered a substitute for pasture taps. (If a stock pond is short of water or a well goes dry and water service is sought, the producer would need to request a pasture tap service and would become a subsequent user.)

Application for temporary service is determined and authorized on a case-bycase basis. Such services in most cases must be removed prior to freeze-up. Please contact the SWA office with any questions or for additional information concerning temporary service.
