





Legislative session brings opportunities, challenges for water development

Every legislative session brings exciting opportunities and challenges for water development projects. The 59th Legislative Assembly is no different. This session includes three bills that will impact the Southwest Water Authority (SWA) including HB 1021, HB 1153 and HB 1274.

HB 1021 - ND State Water Commission (SWC) Budget

As always, funding determines the rate of construction along the Southwest Pipeline Project (SWPP). A total of \$15.5 million is needed to complete Phase II of the Medora, Beach, Morton Service Area, which will serve the community of Golva and over 430 customers in Stark, Billings, Golden Valley and Morton

Counties. The amount of funding secured through the North Dakota Legislature, in HB 1021, will influence our rate of construction over the next two years. The Governor's proposed budget included \$2.6 million for the SWPP, approximately \$12.9 million short of our needs.

As a member of the North Dakota Water Coalition, we are well aware of North Dakota's critical water needs: Grand Forks flood control, Devils Lake outlet, Fargo flood control, rural water projects and others. The North Dakota Water Coalition members identified a list of critical statewide water needs totaling \$13.6 million. These needs were presented to both the House and Senate. If fully funded, this request would increase state funding for the SWPP from \$2.6 to \$7.6 million.

While the House amended HB 1021 by cutting

\$2.1 million out of the Governor's budget, we are hopeful that the Senate ammendments to restore funding and increase bonding limits will be passed.

A key issue in the SWC funding discussion is how to utilize the Water Development Trust Fund (WDTF). This fund was formed through tobacco settlement money and is earmarked for water development, i.e. rural water projects, irrigation, flood control and other water projects. The debate is whether or not to fund the SWC operations entirely from WDTF, as they have the last two sessions, or fund SWC operations from the general fund and utilize WDTF monies for water development.

Under the current House amendment, the SWC would be funded mainly through the WDTF. The Water Coalition, however, is asking the Senate to fund the SWC through the general fund and to increase the SWC bonding limit from \$60 to \$74 million. Either option (funding SWC through the general fund and/or increasing the bonding limit), or a combination of the two, would enable the SWC to meet the \$13.6 million critical needs request.

HB 1153 - SWC Bonding Authority

This bill provides additional authorization for the SWC to bond for water projects. This bill was passed by both the House and Senate.

HB 1274 - SWPP Water Delivery Rates and Charges for Large Industrial Users

The North Dakota Century Code currently limits the amount of water the SWPP can provide for industrial use. This limitation was applied by the legislature when SWPP was first formulated. Its intent was to prevent large industrial users from becoming customers without paying a prorated share of construction costs up front based on their needs. However, mainline construction is now complete and additional capacity is available on a first come first serve basis.

HB 1274 evolved from Red Trail Energy's request to utilize raw water from the SWPP for their proposed ethanol plant. A hydraulic review of their needs indicates the SWPP has the capacity to provide service. When Red Trail Energy becomes operational, they have the potential to become one of the system's largest users. Large users in the

system help stabilize water rates and improve the efficiency of the system. This bill was passed by both the House and Senate.

Billing explanation, addresses requested

Southwest Water Authority customers who received service after October 1, 2004, can expect their first monthly billing in May. This bill provides a credit of 1,000 gallons of water to flush your system. Every month thereafter, a minimum, based upon your signup, will be posted to your account. It includes 2,000 gallons of water. If you signed up for a pasture tap, your first bill will be prorated from May to October, 2005. Please call our office if you

Medora, Beach, Morton Phase II Construction Status

If you have driven along Highway No. 10 east of Belfield to Beach in recent months, you probably noticed quite a bit of construction activity, including three new water tanks dotting the landscape. The largest of these tanks, 750,000 gallons, is located 1.5 miles east of Belfield. The second largest tank, holding 480,000 gallons, is southwest of Fryburg, and the third tank, located four miles east of Beach, holds 420,000 gallons. These tanks provide water storage and gravity service to rural customers and communities in the Medora, Beach, Morton Service Area.

You may have also noticed black lettering on the tanks, such as "Southwest Water" on the Belfield and Fryburg tanks or "SW Water" on the Beach tank.

From Belfield to west of Medora, substantial construction occurred. One pipeline contractor installed about 46 miles of PVC pipe and service lines to 70 rural water customers. Approximately 37 of those customers now enjoy quality water from the Southwest Pipeline Project (SWPP). The remaining 34 customers will connect to the pipeline this spring. This contract also

provides domestic water service (not irrigation) to Bully Pulpit golf course, the new Badlands Ministry resort area, West Medora Campground, Buffalo Gap and Eagles Ridge Lodge and the Painted Canyon Rest Area.

SWPP crossed a major milestone in the Medora-Beach area late last year – installation and operation of the main transmission pipeline. Northern Improvement Company, Bismarck, North Dakota, successfully installed 48.9 miles of pipe from Belfield to Beach. They also installed two booster pump stations and several pressure reducing valve vaults, three tank control vaults and meter vaults that serve Medora, Sentinel Butte and Beach. Service to the cities of Beach and Sentinel Butte began in October, 2004, while Medora began taking water in February, 2005.

With Phase I complete, SWA and the ND State Water Commission are focusing on securing funding for Phase II of the Medora, Beach, Morton Service Area. However, the level of funding is still unknown. Construction cost of Phase II is estimated at \$15.5 million.
