## Manager's Message

With spring upon us, everyone here is gearing up for a new construction season as well as meeting the needs of our current customers during the upcoming warm summer months. Bid openings were recently held for several contracts for construction on the Southwest Pipeline Project. The North Dakota State Water Commission (SWC) met on March 17, 2008, and awarded the

following contracts: the Trotters Pocket, located in northern Billings County, the Fairfield Service Area north of Belfield, the West Killdeer Mountain Pocket located in western Dunn County, the Grassy Butte Pocket located in southeast McKenzie County, and the Fairfield Reservoir. All of these contracts will serve at least 420 customers through more than 400 miles of new pipeline construction. The Fairfield Service Area will include a VFD Booster Station and a 197,300 gallon reservoir.

We received word that USDA Rural Development (RD) approved the loan and grant application of the SWC for the Fairfield Service Area in the amount of \$5 million. This will consist of a loan in the amount of \$3,005,000.00 and a grant of \$1,995,000.00. With the funding for the Fairfield Service Area being provided by USDA - RD, other funds that were appropriated for the SWPP in the current biennium can be used to complete the Medora Beach Service Area. This will also allow the SWC to fund a pilot project at the Basin Electric intake to study treatment options for the Oliver, Mercer, North Dunn (OMND) Phase in the current year. This in turn will allow design to commence on the water treatment plant (WTP) in Mercer County, which will serve the OMND Service Area. Plans will also be underway for design of the main transmission line from the raw water tanks located approximately seven miles north of Zap, which is also the future home of the WTP for the OMND Service Area.

Our sincere thanks go out to the state and federal USDA - RD offices for the additional funding. The ND USDA - RD office has gone above and beyond the call of duty in the submission process to aid in obtaining funding for SWPP. I would like to specifically thank Clare Carlson, State Director, Dale Van Eckhout, Business & Community Program Director, and their staff for all their efforts, especially Jane Tesch, Rural Development Loan Specialist. The SWC, SWA and the citizens who will be served in the Fairfield Service Area are truly grateful for their efforts and for the funding.

I would like to take this opportunity to welcome George Saxowsky to the SWA Board of Directors. George was sworn in at the March Board meeting and is our new board member from Morton County. He was appointed by the Morton County Commission to replace Steve Tomac who recently resigned his position on the SWA Board of Directors. Thank you, Steve, for your years of service to SWA and the SWPP. We look forward to working with George as our newest board member to SWA.

The March Board of Directors meeting for the SWA was held in Hazen. Representatives from the North Dakota State Legislature, the ND SWC, the city of Hazen, Mercer County and the Mercer County Water Resource Board were in attendance. We were pleased that they all took time out of their busy schedules to attend the meeting and learn more about SWA and the SWPP and future service to this region.

Here are some tips on how to read your updated monthly billing statement. Illustrations (shown below, right) indicate which area of your statement each number coincides, beginning with your payment stub.

1. Please Show Meter Reading Here: Include ALL seven digits from your meter/remote, even

if some of the digits are zeros. Do not round up or down.

- 2. Net Amount to be Paid: Amount to be paid by you.
- 3. Route: Code for office use only; indicates general area in which your service is located.
- 4. Account: Your account number.
- 5. Due Date: Date which your payment must be postmarked or placed in drop boxes by 3:00 pm. A \$3.00 late fee will be added to your next bill if your payment is not received on time.
- 6. Mail this Stub with Your Payment: Return the right side of the post card with your payment to the Southwest Water Authority. If you include the nine digit zip code, your payment will reach our office sooner and be processed faster.
- 7. Meter Reading: Both the previous and present month's meter readings are shown here.
- 8. Used: Shows the amount of gallons used.
- 9. Charge for Water: Indicates charge for water used per thousand gallons.
- 10. Monthly Minimum: Amount based on the type of service at signup.
- 11. Misc: Indicates any adjustment to your bill, such as a credit, past due balance or any other charges for services and/or materials.
- 12. Meter Read: The month and day your meter reading was entered.
- 13. Class: Type of service; code is for office use only.

Note that customers in Morton County (including Junction Inn, Burt Service Area and Tower Hills Service Area) and in the Beulah Interim Service Area will see this change in the next few months.
