Manager's Message

Spring is once again in the air, and with it comes another year of construction for the Southwest Water Authority (SWA) and the Southwest Pipeline Project (SWPP). Construction will continue in the Oliver, Mercer, North Dunn (OMND) Regional Service Area.

The OMND water treatment plant (WTP), located seven miles north of Zap, will soon be producing quality water for those living in the region. Construction has been progressing steadily over the past year on the new WTP. Installation of the membranes and the telemetry system are underway. The electrical and mechanical contractors are also working toward completion. Service will begin with water to the communities of Hazen and Stanton. Construction of main transmission lines will provide service to Center and the Missouri West Water System later this year.

The Zap I potable water reservoir and the Center elevated reservoir are also scheduled for completion.

SWA is currently overseeing work on a rehabilitation project at the WTP in Dickinson. The work includes replacing rack and pinion gears and sandblasting and painting in the lime softening basins. The Greenleaf filters have already been repaired, which includes sandblasting, painting, replacing metal flumes with stainless steel, and grouting. Flows have been reduced substantially during this rehab process. SWA is running the WTP 24-hours a day in order to meet demand.

Contract 7-9C, the Zap Phase I Service Area, is anticipated to begin May first and be completed this year. The North Dakota State Water Commission (SWC) awarded the contract to Northern Improvement Company. Zap Phase I will provide service to more than 300 rural customers and include potable water service to the power plants. Zap Phase II Service Area is currently being advertised for bid.

SWA and the SWPP continue to see increased demand for quality water throughout our region, including all regions in the SWA service area - areas built years ago where our citizens are still waiting for that first drink of fresh, clean water from their tap. SWA would like to take this opportunity to assure you we are working diligently to meet the ever-growing needs.

In order to meet the industrial demands of the region, SWA is constructing a water depot east of Dickinson for filling trucks. This will help get the trucks out of town and onto roads designed for the traffic. The water at this location will be raw water, which means it has not been through the total treatment process. It will also be off-peak water, meaning it is water which has been allocated to someone else, but is not currently being used. This will be good for everyone, as it is the most efficient use of our resources.

Water Notes

Summer is a busy time for customers to hook up. If you wish to connect to the pipeline and need your water turned on, we request at least a 72-hour advance notice for our operators to schedule a time with you. Remember to submit your Plumbers Verification Form to our operator or office at the time of hook up.

Please be reminded that you must receive official notification from the Southwest Water Authority office before hooking up. Those who enter the meter pit and/or turn on their own water, whether it be customers and/or plumbers, are in violation of the rules and regulations established by the Southwest Water Authority. If water is turned on without notification from our office you will be fined and possibly disconnected for system tampering.

Rules and Regulations Section XIX-G states:

Southwest Water Authority may, in addition to prosecution by law, permanently refuse service to any customer who tampers with the system, including a meter or other measuring device.

Accordingly, Southwest Water Authority has adopted a penalty schedule for use of water without authorization as follows:

1st occurrence 100.00 penalty plus service charge = 170.00

2nd occurrence \$250.00 penalty plus service charge = \$320.00

> 3rd occurrence Disconnection of service
