## From Mary Massad, Manager/CEO



Southwest Water Authority celebrated National Drinking Week, May 7-13th. In honor of this annual event, Southwest Water Authority's (SWA) Board of Directors passed and signed a resolution of their on-going support of drinking water. SWA takes very seriously reliable, guality drinking water. The guality of SWA's water can be attested to in our annual Consumer Confidence Report, which will be mailed by June 1st.

If you are a customer of SWA, you also play an important

role. By being connected to the system you are helping to ensure you continue to have a reliable source of safe water. When you pay for the water you use, this payment goes toward the on-going operating costs for maintenance of the miles of pipeline and needed upgrades to the system.

Most of your base water fee, however, is sent back into the North Dakota's Resources Trust Fund (RTF) to pay back the construction costs of the Southwest Pipeline Project (SWPP). To date, that adds up to over \$54 million.

Going into summer, even more water lines will be installed for the people in the Mercer and North Dunn Counties. Work also continues on the new water treatment plant in Dickinson with an expected completion date by the end of 2017. The work is progressing with adding a parallel water supply line and micro-tunneling out of Renner Bay. The purpose of these projects is to increase the amount of raw water capacity to help meet the growing demands in southwest North Dakota.

Legislative House Bill (HB) 1020 has approved funding for water in North Dakota. The State Water Commission (SWC) will be appropriating funds over the biennium. The Water Topics Overview Committee will be appointed in the coming months and the first meeting is expected to be in August.

On behalf of SWA's Board of Directors and staff, we are thankful for the progress and funding of the SWPP. For it is only with the local, regional and state support, we can continue on our mission: Quality Water for Southwest North Dakota and realize a vision: People and Business Succeeding with Quality Water.

## Reclamation & Weed Control

Each spring, when the snow melts and the ground thaws, landscapes will often reveal settling. Beyond the control of the Southwest Pipeline Project's (SWPP) contractors are the heavy snow and rain, which combined with run off and fluctuating temperatures can cause trench settlement. Settlement can happen over time or immediately after construction. If you observe this scenario in an area where water pipelines have been installed, please contact SWA as soon as possible. We're here to help.



Southwest Water Authority (SWA) is again working to coordinate control of noxious weeds along recently installed pipelines. Spraving takes place according to the specifications as not all weeds can be controlled at the same time. Seeding depends on the time of year and weather conditions. Quite often, issues are not discovered until the landowners are seeding their crops. When you've discovered areas in need of either weed control or seeding, please let us know. SWA works with landowners to coordinate these efforts.

SWA needs your help to be our eyes and ears in rural construction. With more than 5,000 miles of pipeline, it is difficult to know where the needs are located. It is very important for you to contact the office in Dickinson if you have reclamation issues or weed control needs.

As part of the celebration, SWA's Board of Director's passed a resolution to recognize the importance of quality water, posted information to SWA's website, and a created a fun and informative display at the Dickinson Area Public Library, a star library in North Dakota.

It is expected when we turn on a faucet, clean, safe quality water to come from the tap. From the crops produced to the food we eat, water is an essential resource to virtually everything we do. Whether the water provider's source is surface water like it is on the SWPP, or groundwater, the end product is the result of a thorough treatment and distribution process to make sure it is safe to drink.

That is why SWA's staff continuously delivers safe and reliable drinking water to its service areas through two water treatment plants and nearly 5,500 miles of water pipes. These operators are responsible for the ongoing testing, treatment, and distribution of your drinking water.

# Keep Your Water Flowing Clear



Hot water is a wonderful thing. But, did you know that regularly flushing your water heater's tank is important for maintaining its efficiency and longevity? It also can make a difference as to whether your hot water runs clear or even has odors.

What happens? When an electric or gas water heater isn't maintained or just gets old, it can develop a sediment (rust, minerals, etc.) buildup in the bottom of the tank. When this happens, it can cause the hot water to turn a brownish color and even cause odor issues. Contractors have gotten back into the installing water pipelines for those waiting for quality water in Mercer and North Dunn Counties. Work also continues on the new 6 MGD Supplemental Water Treatment Plant in Dickinson. Increasing the overall capacity of water supply delivered to southwest North Dakota is progressing with the microtunneling project in Renner Bay.
