Quality Water for Southwest North Dakota

#### From Southwest Water Authority

As we go into a new year, all of us at Southwest Water Authority (SWA) want to express our extreme gratitude to everyone who helped us deal successfully with all the challenges in 2020. These are the invaluable people who continue to believe in our mission and share our vision of People and Business Succeeding with Quality Water. So, "Thank You!" to SWA's professional staff and its dedicated Board of Directors, consultants, and all of the regional and state partners helping us bring quality water to southwest North Dakota. Even though three people were recognized with awards (read inside), all of the people who work with and for SWA are award-winning people.

Especially, we want to thank the Southwest Pipeline Project's (SWPP) owner, the great state of North Dakota – and most especially our State Water Commission (SWC), legislators, and Governor Doug Burgum and his staff. If it were not for state ownership and the unique funding of the project, the economic benefits and quality of life impacts that quality water brings to southwest North Dakota likely would never have happened.



Construction continued even during the pandemic, including completion of the Second Davis Buttes and the Second Belfield reservoirs. These reservoirs provide an additional 1.75 million gallons of treated water storage to help meet peak demands.

Preliminary design and easement acquisitions are ongoing for the Main Transmission Line expansion from the Davis Buttes, Belfield and New England reservoirs, back to the Ray Christensen Pump Station in Dickinson. This expansion will further increase the SWPP's water-distribution capacity. Also, construction continues on the supplemental intake at Renner Bay on Lake Sakakawea.

This year marks the 67th Legislative Session in the North Dakota Legislature and SWA's Board of Directors and management are working to aide in obtaining funding for the SWPP. At a recent monthly board meeting, Senator Rich Wardner



presented his legislative proposal for a bonding bill which could potentially free up RTF money for water projects such as the SWPP. SWA will be working diligently this session in support of the SWC's agency funding bill, House Bill 2020. Securing Project funding is always at the forefront of our endeavors.

Due to the loss of the one-mill levy at the end of 2020, SWA's Board of Directors approved a small rate increase, effective January 1, 2021, to help offset the lost revenue. This translates to an additional ten cents per thousand gallons for both rural and contract customers, and a one dollar increase on the rural monthly minimum.

Certainly, there is no more important endeavor in sustaining human life than sustaining the supply of quality water. Yet, hundreds of people in southwest North Dakota remain on SWA's waiting list for connection to its award-winning quality water — a strong motivation for SWA to remain vigilant in our mission and diligent in gaining the SWPP's required funding. Here at SWA, the dream of water for southwest North Dakota continues — because quality water matters.

## Rate Increase to Offset Mill Levy Loss

Towards the end of each year, the SWA Board of Directors reviews current and forecasted financials to determine the need for any rate changes. At its October meeting, the Board approved a small rate increase, effective January 1, 2021, primarily to offset the expiration of SWA's one-mill levy.

The net effect of the decision was a ten-cent increase per 1,000 gallons of water to the rural customers. Rural rates per thousand gallons will go from \$6.26 in 2020 to \$6.36 in 2021, and the rural minimum will increase by \$49 to \$50 per month. Rural customers in southwest North Dakota continue to pay less than one cent per gallon of water, ranking just about average in comparison with other rural water systems across the state.
