Quality Water for Southwest North Dakota



Summer is synonymous with water. It is when people use it the most. It is also when construction needs to happen. Southwest Water Authority (SWA) spent the summer under construction. The Main Transmission Line (MTL) upgrades in all directions out of Dickinson are nearing completion. The recently painted 400,000 gallon Taylor Elevated Tank will be put into operation this fall. This tank is the first of SWA's Strategic Hydraulic Improvements to help meet the growing need for quality water in southwest North Dakota. Progress continued on the supplemental intake at Renner Bay. The photo below shows the 36" welded steel pipe that will be floated onto the Missouri River and pulled back into place once Horizontal Directional Drilling (HDD) has finished. Once the intake is complete, construction of an Intake Pump Station will begin.

During the early summer SWA meetings, the Board of Directors unanimously passed a "Resolution of Appreciation" for members: Larry Bares, Director 2002-2022 representing City of Dickinson; Marie Johnson, Director 2010-2022 representing Mercer County, and Steve Schneider, Director 2010-2022, representing Stark County. All three were recognized for their on-going leadership, advocacy, and compassion for water quality. The board further resolved that individually all three board members helped SWA to continue realizing its vision of *People and Business Succeeding with Quality Water.* We wish them well in their future endeavors!

With any public water system, pipes need to be maintained and eventually replaced. The Southwest Pipeline Project (SWPP) is no exception. Some of the water pipes have now been in the ground since 1986, which is why from September through October segments of the raw water ductile iron pipe near Taylor are being replaced. The pipe will be replaced in five sections, with one per week being completed. Coordination of construction, water storage and treatment practices should allow minimal interruptions to water service.
